#### Pennsylvania Department of Aging Health and Wellness Program...

#### What is it and how can it help me?

The mission of the Health and Wellness Program is to promote healthier lifestyles among older Pennsylvanians so that there is a measurable improvement in their quality of life.

The vision is to empower older Pennsylvanians with the knowledge and direction to age and live well by providing effective research-based programs in their communities.

What are the goals of the Pennsylvania Department of Aging Health and Wellness Program?

-Abolish the myth that inevitable functional decline comes with age

-Empower older adults with the information they need to age well

-Support older adults in making lifestyle changes to improve their overall health

-Reduce utilization of the healthcare system.

Here in Clearfield County, the Area Bingocize - Helps improve functional Agency on Aging utilizes evidencedbased programing to address management of chronic health conditions, exercise and fall/injury prevention.

What programs are offered through our agency?

Chronic Disease Self-management Program (CDSMP) - Aims to improve health status of individuals with chronic health conditions by teaching practical skills for managing their condition. Participants gain confidence and motivation needed to manage every day challenges of living with their chronic condition. There are 2 additional programs that address specific needs of individuals living with diabetes (Diabetes self-management Program) and chronic pain (Chronic Pain Selfmanagement Program).

Healthy Steps for Older Adults (HSOA) - Provides education to increase fall awareness and strategies to help reduce falls and injuries from falls.

Matter of Balance (MOB) - Provides strategies to reduce the fear of falling, decrease fall risk and promote physical activity.

Stay Active and Independent for Life (SAIL) - Physical activity program that helps reduce fall risk factors by helping to increase strength and improve balance.

Healthy Steps in Motion (HSIM) -Strives to reduce the risk of falling by building body strength, increasing flexibility and improving balance.

performance including lower/upper body strength, gait, balance and range of motion. Improves aspects of cognition (executive function) and increases social engagement.

Powerful Tools for Caregivers - A selfcare education program for family caregivers to improve: self-care behaviors, management of emotions, self-efficacy and use of community resources.

Healthy Ideas - Offered to reduce the severity of depressive symptoms in older adults by empowering individuals to manage their depressive symptoms through a behavioral activation approach that encourages involvement in meaningful activities.

Care Transitions - Provides tools for individuals recently discharged home from a hospital or rehabilitation center to help improve quality and manage risks associated with transfers between health care settings. Some topics include medication changes and management, identifying red flags for chronic conditions and interacting with your physician to better manage care at home and prevent readmission to the hospital.

Ombudsmen serve as advocates for residents who live in long-term care facilities, such as nursing and personal

care homes. They assure that residents enjoy quality of care and quality of life and that resident rights, guaranteed under federal and state law, are respected. 

#### **Medicare Now Covers Coronavirus Testing**

You may be hearing the Coronavirus (officially called 2019-Novel Coronavirus or Covid-19) in the news. While there isn't a vaccine yet, Medicare is still here to help. Medicare Part B (medical insurance) will cover a test to see if you have Coronavirus. This test is covered when your doctor or other health care provider orders it, to help your health care team diagnose or rule out a suspected illness or condition. It will be covered by Medicare B if you got the test on or after February 4, 2020.

You usually pay nothing for Medicare-covered clinical diagnostic laboratory test. Note: Your provider will need to wait until after April 1, 2020 to be able to submit a claim to Medicare for this test. Seniors on Advantage Plans should check with their plan.

To prevent the spread of this illness or other illnesses including the flu, here are some tips to follow:



- Stay home when you're sick.
- See a doctor if you think you are ill.
- Let your health care provider know if you think you might have been exposed to the coronavirus before seeing them so they are prepared.
- Do not travel to affected areas (keep informed).
- Avoid large crowds.
- Keep informed.

• Beware of SCAMS: there is no vaccine to prevent you from getting the virus.

...Callers threaten you with arrest or other legal action.

- Suspend your Social Security number
- Demand immediate payment from you
- Require payment by cash, gift card, pre-paid debit card or wire transfer

#### **BE ACTIVE!**

Operations Specialist for the Ombudsman Program for the Clearfield County AAA. Jeanne was born at Clearfield Hospital, hospital coffers. She was responsible for farm field measurements, aerial compliance (crop measurements from an airplane) and measuring grain bins and silos for crop loans. While still doing field work, she became a Program Assistant in the office and later became County Executive Director for Jefferson and Elk Counties where she remained for 19 years and 11 months.

> The Ombudsman Program originated under Federal Legislation of the Older Americans' Act. It is administered by the PA Department of Aging through the local offices of the Area Agencies on Agin most counties. Ombudsmen are certified through a rigorous training program and receive periodic training updates. All must pass a criminal background check, undergo orientation and complete job shadowing with an experienced ombudsman.

When asked about her thoughts concerning her years as an ombudsman, Jeanne said, "Eighty-five percent of nursing home residents have no visitors. Some residents have outlived their friends and families.
